#### **a. Chief Oatley's report:**

- There were seven (7) calls total last month.
- Wages are unchanged
- I gave Donna a couple of invoices for reimbursement
- Brian Wiggins is taking the instructor 1 class. We will pay for his book. The class is covered by SMOKE
- Fit and flow testing is in August 27th
- Hose testing is due in September 15th
- The truck pump testing I haven't scheduled yet
- Still waiting to hear from Enbridge regarding the grant application we submitted. Should hear soon. There are other grants out there. I haven't applied for them yet.
- The Amish dinner in the fall was a good fundraiser. Haven't heard from them yet. That was a good fundraiser last time.
- The pumper replacement; we put together a Spec package and sent that to local fire truck dealers and Midwest. We should start getting prices on that for budgetary reasons at this time.
- We will be at the Riverfest starting around 11am down in Reed River Park like every year. Gibby's Hometown Bar & Grill donated all of the buns, chips, pickles, BBQ sauce.

Old Business:

- a. Supervisor Kline communicated we will not hear anything about the grant money for the New Fire Station until March of 2026

New Business:

- a. The County came up with a Cardiac Arrest page group. We get paged and alerted on our radios. If we are in the vicinity, we can respond basically as a bystander. This is to help with faster responses to someone in need of CPR. There are some rules to this. It is going around the County for approval. I wanted to let you know before I sign off on this.
