# Floor Business:

- a. Chief Oatley's report:
  - Slow month for runs. Busy month administration wise. The state a few years ago implemented you have to have continued education credits so you can maintain your fire license. This was the first of a three-year period where everyone had to sign into the state website, known as SMOKE. This was a way for the State to know that people are doing the training. If you don't do the training, your fire license can be revoked. All of our guys are in good shape. The training can be done internally, so we have a once-a-month training session.
  - Andy and I went to a Chief's meeting this past month.
  - Sunni will be starting the Academy.
  - Truck pump testing is coming up. I will get that scheduled.
  - The Enbridge grant was denied. Probably asked them for too much money. I'm trying to figure out where the limit is with them.

  - Bailey Griffith did pass his certification.
