The minutes of the December 2, 2025 regular meeting of the Mendon Township Board were submitted for consideration. A motion was made by Mathews, supported by Griffith to approve the minutes. Motion carried.

Floor Business:

- a. Dale Hutson – SEV values were provided to the board. Dale explained what the numbers are and the changes for 2026. Dale also provided 2025 property sales, which includes residential, commercial, agriculture.
- b. Keith McClish will not be able to make BOR meetings in February.
- c. I do a training class every year – that is coming up in February.
- d. Consideration to approve the “Resolution Indemnification and Compensation of Former Zoning Administrator, Douglas Kuhlman was brought to the board for approval. A motion was made by Mathews, supported by Hart to approve the resolution #010626. Motion carried by roll call; Supervisor Kline, yes, Treasurer Griffith, yes, Trustee Hart, yes, Trustee Mathews, yes and Clerk Cupp, yes.
- e. Supervisor Kline: We were billed for Simpson Rd. in one payment instead of two. On December 16, 2025 I received a call from John Lyndsey regarding South Shore Drive for asphalting that road. The price for this is \$38,000.00 for that half a mile of road. Mathews: Is the money in the budget? Griffith: The money is there. A motion was made by Mathews, supported by Griffith to approve the bid from the road commission to asphalt this road. Motion carried.

Old Business:

- a. Township hall – Supervisor Kline indicated the furniture should be getting moved back in in the next week.

New Business:

The treasurer's report was submitted for approval. A motion was made by Cupp, supported by Hart to approve the treasurer's report. Motion carried.

The December bills were submitted for consideration and approval of payment. A motion was made by Griffith supported by Mathews to approve the bills. Motion carried.
